

Affidavit of Financial Support for International Students

The Bureau of Citizenship and Immigration Services (BCIS) requires that all students provide evidence of adequate funds to meet the financial obligations of enrollment at a U.S. university. In order for the Admissions Office to issue you a new I-20, we must verify that you have provided us with <u>updated</u> documentation of financial support.

- If you will use your personal funds as the source of financial support, you must provide us with a copy of your bank statement showing the availability of at least \$38,292 (undergraduates) or \$36,562 (graduates)**. Bank statements can be no older than 6 months.
- If you will be supported by a private sponsor (family member, friend, private institution etc.), the sponsor must either complete and sign the Statement of Financial Obligation below or provide a letter declaring their relationship to you and their intent to provide financial support throughout your studies. In addition, sponsors must also provide an official bank statement showing the availability of at least \$38,292 (undergraduates) or \$36,562 (graduates)** in liquid assets. Bank statements can be no older than 6 months.

**M.B.A. applicants must show the availability of at least \$40,882.
