Sexual Harassment is unwelcome verbal, nonverbal, or physical conduct of a sexual nature.

It may include sexual advances, requests for sexual favors, or other conduct of a sexual nature where:

1. Submission to or rejection of the conduct is the basis for a decision related to employment or education; or

2. The conduct is severe and persistent enough to create an intimidating, hostile, or offensive environment.

Who Can I Talk To?

It is hard to know what to do, how to feel, or what your options are after experiencing sexual harassment. Please remember that we are here to help you. If you are interested in seeking support, you can contact a **Center for Advocacy, Prevention and Empowerment** or **Student Psychological Services**. These resources will keep your information completely confidential.

To report the incident to the University, you can contact the **Title IX Office**. To make a criminal complaint, you can call the **University Police** 24 hours a day, 7 days a week.

Students, faculty, and staff can submit inquiries or complaints to the **Office for Civil Rights (OCR)** by calling (415) 486-5555, TDD (877) 521-2172 or emailing at OCR.SanFrancisco@ed.gov.

What Should I Do?

1. Go to a Safe Place.

Your safety is our top priority. If you do not feel safe, call the University Police immediately at (310) 243-3333 or 911.

Consider contacting CSUDH's confidential Center for Advocacy, Prevention and Empowerment (CAPE) at (310) 243-2567.

2. Understand That What Happened was Not Your Fault.

No one deserves to be sexually harassed.

3. Get Support and Resources.

The CAPE Advocate can provide support and assist you with finding resources and reporting at (310) 243-2567.

4. Consider Notifying the University.

We take all reports seriously and will respond to them promptly and investigate thoroughly, as appropriate. You can make a report to the CSUDH Title IX Office at (310) 243-1025. You are also encouraged to report to the University Police Department at (310) 243-3333. CAPE or the Title IX Office can assist you with this, as well.

What happens if I notify the university?

Report:

The CSUDH Center for Prevention, Advocacy, and Empowerment can assist you with reporting the incident to the University:

The report can also be made directly to the Title IX Office:

The Office will arrange accommodations and interim safety measures.

Intake:

Of you choose to pursue an investigation at CSUDH, the Title IX Office will meet with you to provide information and conduct an intake. Make an appointment by calling.

Investigation:

Then, a trained Title IX Investigator will collect evidence (like photographs or texts), and interview you, the accused person, and witnesses. You may provide witnesses and evidence that may be relevant. The Investigator will complete a report with a finding within 60 working days.

Appeal:

You may appeal the decision to the CSU Chancellor's Office within 10 working days, and they will respond within 30 working days with a final decision.

4

Resolution:

If the final outcome includes a violation of a CSU Executive Order, the accused person will be referred to the Student Conduct Office or appropriate office. You may be invited to conference with the appropriate administrator. A hearing may take place. You and the accused person will be allowed to appeal the sanctions.
